



## REACH Regulation at Check Point China AB

### REACH regulation

With this note we want to inform you about our position under the European REACH (Registration, Evaluation, Authorization and restriction of Chemicals) Regulation EC 1907/2006.

All products we manufacture, import and supply are “articles” as defined in Article 3 of the REACH Regulation.

Importers and suppliers of articles are according to Article 33 of the REACH Regulation obliged to provide information about SVHC substances included in the REACH Candidate List if such substance is present in an article over 0.1 percent by weight.

Delivered articles should furthermore comply with the restrictions laid down in REACH Annex XVII.

### Check Point China AB

Our products do, according to our current data and information we have collected from our suppliers, not contain SVHC substances from the Candidate list over 0.1% w/w, and neither substances restricted (in our type of products) by REACH annex XVII. On the basis of currently available information our products comply with REACH and no further information is required.
